## **Adoption of Minutes:**

A motion was made by Councilman Roth, seconded by Councilwoman Napolitani and carried to adopt the February 17, 2023 regular and executive meeting minutes and the March 4, 2023 budget meeting minutes of the Belvidere Town Council.

Councilwoman Napolitani advised that the interviews for the Court Violations Clerk have been conducted, a candidate has been chosen and accepted the position with a start date of April 10<sup>th</sup>.

Kevin Benbrook advised regarding a letter to the bank of the homeowner to secure financing for the completion of their home elevation project. Said letter will spell out the reimbursement grant

A motion was made by Councilwoman Napolitani, seconded by Councilwoman Koop and carried authorizing Mayor Miers to execute the above referenced letter.

A motion was made by Councilman Roth, seconded by Councilwoman Napolitani and carried to adopt Resolution No. R2023x25.

**RESOLUTION NO. R2023x25** 

TOWN OF BELVIDERE

WARREN COUNTY, NEW JERSEY

A RESOLUTION DESIGNATING BLOCK 38/LOTS 17 AND 18; BLOCK 42/LOTS 2 AND 3; BLOCK 45/LOTS 5,7 AND 8; BLOCK 46/LOTS 2, 3, 4 AND 5; BLOCK 47/LOT 10; BLOCK 48/LOT 7 AND PORTIONS OF SIXTH STREET, SEVENTH STREET, HARDWICK STREET, KNOWLTON STREET AND INDEPENDENCE STREET RIGHTS-OF-WAY AS A NON-CONDEMNATION REDEVELOPMENT AREA

WHEREAS, the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1, et seq. ("The Redevelopment Law") authorizes municipalities to determine whether certain parcels of land located therein constitute areas in need of redevelopment; and

WHEREAS, pursuant to resolution No. R2022x48 adopted on May 9, 2022, the Town Council ("Council") of the Town of Belvidere ("Town") authorized and directed the Belvidere Planning Board ("Board") to conduct an investigation to determine if the following properties, or nay portion thereof ("Study Area"), meet the criteria set forth on the Redevelopment Law and should be designated as a Non-Condemnation Redevelopment Area, as that term is defined by the Redevelopment Law:

- 1. Block 38/Lots 17 and 18
- 2. Block 42/Lots 2 and 3
- 3. Block 45/Lots 5, 7 and 8
- 4. Block 46/Lots 2, 3, 4 and 5
- 5. Block 47/Lot 10
- 6. Block 48/Lots 7
- 7. Portions of Sixth Street, Seventh Street, Hardwick Street, Knowlton Street and Independence Street rights-of-way.

WHEREAS, the Board conducted an investigation of the Study Area to determine whether it should ve designated as a Non-Condemnation Redevelopment area in accordance with the criteria and procedures set forth in N.J.S.A. 40A:12A-5 and 40A: 12A-6; and

WHEREAS, as parr of its investigation, the Board directed Paul Sterbenz, P.E., PP and Daniel Bloch, P.P., AICP to prepare an area in Need of Redevelopment Investigation Study ("Area in Need Study") for the Board for its consideration in determining whether the Study Area should be designated a Non-Condemnation Redevelopment Area and said investigation was completed and is entitled "Non-Condemnation Area in Need of Redevelopment Investigation - Block 38/Lots 17 and 18; Block 42/Lots 2 and 3; Block 45/Lots 5, 7 and 8; Block 46/Lots 2, 3, 4 and 5; Block 47/Lot 10; Block 48/Lots 7; Portions of Sixth Street, Seventh Street, Hardwick Street, Knowlton Street and Independence Street rights-of-way; and

WHEREAS, the Board conducted a public hearing on January 3, 2023 with notice having been given pursuant to N.J.S.A. 40A:12A-6(b)(3); and

WHEREAS, at the public hearing the Board reviewed the Area in Need Study and heard testimony from Paul Sterbenz and Daniel Bloch; and

WHEREAS, Paul Sterbenz and Daniel Bloch concluded in the Area in Need Study and testified to the Board at the pubic hearing that there is evidence to support the finding that the Study Area satisfies the criteria for a Redevelopment Area designation as set forth in N.J.S.A. 40A:12A-5 (b), (c), and (d); and

WHEREAS, at the public hearing, members of the general public were given an opportunity to be heard and to address questions to the Board, Paul Sterbenz and Daniel Bloch concerning the potential designation of the Study area as a Non-Condemnation Redevelopment area; and

WHEREAS, after completing its investigation and public hearing on this matter, the Board concluded, with the exception of Block 48/Lot 8, that there was sufficient credible evidence to support findings that satisfy the criteria set forth in the Redevelopment Law, particularly in N.J.S.A. 40A:12A-5 (b), (c), and (d) for designating the Study Area as a Non-Condemnation Redevelopment Area and that said designation is necessary for the effective redevelopment of the area comprising the Study Area; and

WHEREAS, the Board made a finding, based upon a review of the Investigation Report and Testimony of the professionals and public that Block 48/Lot 8 does not meet ther statutory criteria to be deemed an area in need of redevelopment, and

WHEREAS, in accordance with the Redevelopment Law and as approved by motion, dated January 3, 2023m the board recommended to the Council that the Study Area defined in Resolution No. R2022x48, with the exception of Block 48/Lot 8, be designated as a Non-Condemnation Redevelopment Area; and

WHEREAS, the Board's findings, conclusions and recommendations relative to the designation of the Study Area with the exception of Block 48/Lot 8, as an area in need of redevelopment are summarized in a resolution memorialized by the Board at its meeting on February 7, 2023; and

WHEREAS, the Council has reviewed the said resolution adopted by the Board;

NOW, THEREFORE, BE IT RESOLVED by the Belvidere Town Council as follows:

- 1. The Council hereby agrees with and adopts and incorporates the findings of fact and conclusions of law of the Board which are set forth in its resolution dated February 7, 2023 relative to the Study Area.
- 2. The Council specifically agrees with the conclusions of the Board that the Study Area, with the exception of Block 48/Lot 8, meets the criteria in the statute for a Non-Condemnation Redevelopment Area.
- 3. Block 38/Lots 17 and 18; Block 42/Lots 2 and 3; Block 45/Lots 5, 7 and 8; Block 46/Lots 2, 3, 4 and 5; Block 47/Lot 10; Block 48/Lots 7; Portions of Sixth Street, Seventh Street, Hardwick Street, Knowlton Street and Independence Street rights-of-way.
- 4. This resolution shall be transmitted by the Municipal Clerk to the Commissioner of the New Jersey Department of Community Affairs pursuant to N.J.S.A. 40A:12A-6b(5)c.
- 5. Within ten (10) days of the Council's adoption of the within resolution, the Municipal Clerk shall serve the within resolution upon all record owners of property within the Non-Condemnation Redevelopment Area, this whose names are listed on the Tax Assessor's records and upon each person who filed a written objection thereto and stated, in or upon the written submission, an address to which said notice of the determination and resolution may be sent.

**A motion** was made by Councilman Roth, seconded by Councilwoman Napolitani and carried authorizing the submission of the above referenced grant with a letter of support from the Belvidere Town Council.

Mayor Miers - met with Beth Styler Barry regarding the dam removals. Ms. Barry will coordinate an outdoor site meeting with residents. Paul Sterbenz will be submitting a grant application for \$75,000 for the required stormwater work.
